Michael filled the casual vacancy position on the Sport SA Board before being appointed President in September 2015.



## **President's Report**

With the ongoing uncertainty around Covid there has never been a more critical time to have a strong and viable peak industry body. The value of having a strong advocate for the industry is immeasurable and the many other services such as the State Sports Dispute Centre, phone and email advice, Industry skills training centre and corporate partner benefits have all grown over this past year. We are all acutely aware that COVID-19 has been especially hard for the sporting industry and your hard work, passion and resilience is not only recognised but valued and greatly appreciated.

Advocacy remains the key pillar of our strategic plan. We have continued to be your voice at all levels of government and in particular we have advocated for a reversal of the **disastrous partnership funding**. To have \$2 million of the \$2.3 million funding pool directed outside of the sector is devastating for the industry. We heard you loud and clear on this and we have lobbied both sides of Government to return this vital funding to the sector. Disappointingly the Government and Office for Recreation, Sport and Racing have defended this decision and have made no commitment to return the funding to the sector. This, despite their own words in the grants review that the purpose of the partnership grants was:

- To support projects that enhance the sport and recreation sector and industry through addressing priorities set out in Game On.
  and
- Funding would be directed at: Any legal entity that supports sport, recreation or physical activity.

We will continue to advocate on your behalf on this matter.

Despite the need to cancel the annual sport awards this year we were able to host the Hall of Fame as a stand-alone event, inducting five very worthy new members and elevating Anna Meares to Legend status. Given the success of this event, the decision was made to maintain this as a stand-alone event in February each year, with the sport awards to remain annually in November.

After the postponement of the 2019 South Australian Masters Games we were able to host the Copper Coast Games in conjunction with the Copper Coast Council. This was a highly successful event with a record 1651 participants.

Training remained a priority as well as support for members through the state sport dispute centre, both of these services have proven to be very popular with members.

Throughout the last twelve months we have been working with the Marleston Foundation to assist them in bringing the Marleston sport and community centre to life. Marleston will be a unique facility, never before seen in Australia, which brings together a number of sports under a shared services model along with a shared use facility. I congratulate Marilyn Tregilgas and the Marleston Foundation on this inspiring vision and I thank you also for putting your faith in Sport SA to work with you to make this vision a reality.

Finally, my thanks to the Board of Sport SA who have continued to work very collaboratively and efficiently to ensure we have a strong and viable organisation. My thanks also the Leah and the Sport SA staff who have worked tirelessly to ensure our members services and events remain top quality and accessible to all.

## **Chief Executive Officer's Report**

The return to sport following the Covid lock down proved to be an important time for us as a peak agency. The required support, advice and reassurance was critical in ensuring the industry was well informed and confident in applying the Directions, which at times appeared to be changing almost daily. Our multiple communication channels allowed for timely and accurate advice to members and the broader industry. None was more popular than our Hooked on Sport podcast, in collaboration with Wallace Long of C2M and Ben Hook. Over 40 000 listeners tuned in to hear the advice on the directions as each new iteration was released. My personal thanks to Wallace and Ben for making this possible.

Advocacy occurred on many fronts. Multiple meetings were held with the Treasurer to ensure Covid support funding flowed to the industry. This included successful lobbying to provide grants to clubs and organisations that have no paid staff.

Our industry training proved very popular with 47 sport courses successfully delivered to the South Australian sporting industry. Over 460 people participated in the courses from over 30 sports and 115 sporting clubs representing a wide-ranging cross section of South Australian sport. The overwhelmingly highly positive feedback from course participants indicates the quality of courses and presenters.

The state sport dispute centre was also very well utilised with 19 cases handled through investigation, mediation and tribunal hearings. With many others managed outside of this formal process through phone and email advice and referrals to our legal partner Gilchrist Connell who provide our members with a one-hour free service. A thanks to our dispute centre panelist for their timely and quality advice to our members. Also, to Adelaide University Law School who have worked with us throughout the year to strengthen the model and provide a suite of resources to support the centre.

We have invested heavily over the past twelve months in bringing a number of members together to realise the vision of the Marleston Foundation to develop a shared use, accessible sport and community centre. This work is an outstanding example of how when we work together, we can achieve something truly remarkable.

The eventual release of the grants review and the disastrous partnership grants consumed an enormous amount of time in advocating and meeting with government to attempt to explain the devastating impact of this on the industry. Sadly this fell on deaf ears with no commitment from the Minister or the Office of Recreation Sport and Racing to reverse what potentially is a loss of \$17 million dollars to the industry. We will not give up on the fight to reverse this ridiculous policy.

I would like to finish by thanking our members for their ongoing faith in Sport SA as their industry leader, evidence in this has been in our growth over the year to 181 members. I would also like to thank our many partners, both new and existing. Without them we could not offer the services that we do. Finally, thank you to the Sport SA staff and volunteers and the Board for their support and backing. Their professionalism, drive, willingness to adapt and unwavering support has made this somewhat difficult year much easier.

## STRATEGIC PLAN PILLAR - 1. Advocacy and Support

Advocacy and support remains at the core of our purpose at Sport SA and this year we continued to work with government to ensure the voice of the industry was heard and that government was held to account on decisions that impacted the industry. Multiple meetings were held with the Treasurer to ensure Covid support funding flowed to the industry. This included successful lobbying to provide grants to clubs and organisations that have no paid staff. Additional advocacy and support activities have included -

- Multiple meetings with Minister Wingard to ensure industry voice and concerns are being heard including successfully lobbying for the delayed release of the SRDIP grant funding and ongoing lobbying to release the results of the 2019 grants review (completed in 2019).
- Daily phone and email support to members through the return to sport
- Meetings with the Marleston working group to bring the Marleston vision to life
- Multiple meetings with both sides of government to advocate for the Marleston Sport and community centre.
- Meeting with Minister Wade to advocate for funding to support Mental Health in Sport project work.
- Regular meetings with Community Sport Australia and Sport Australia to advocate for the value of sport at the national level.
- Successful liaison with SAPOL on behalf of members for exemptions from Covid Directions.








## STRATEGIC PLAN FOCUS AREAS – 4. Reward & Recognition



No other Australian Accounting Standards, Urgent Issues Group Consensus Views or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of noncurrent assets.

The following specific accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this report:

#### a. Property, Plant and Equipment

Property, plant and equipment are carried at cost, independent or directors' valuation. All assets, excludingfreehold land and buildings, are depreciated over their useful lives to the company.

#### b. Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned on a first-in first-out basis and include direct materials, direct labour and an appropriate proportion of variable and fixed overhead expenses.

#### c. Leases

Finance leases are capitalised by recognising an asset and a liability at the lower of the amount equal to the fair value of the leases property or the present value of the minimum lease payments. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period. Lease assets are depreciated on a straight-line bases over their lease term.

#### d. Insurance

A change in accounting policy has resulted in a reduction of Insurance expenditure in the Profit & Loss report for the 2021 year as compared to the 2020 year. In 2020 Insurance was expenses in full for the amount of \$9,167.17. In 2021, as a result of entering into a finance arrangement with Monument Premium Funding, insurance was assigned to the Balance Sheet as a Prepaid Expense with a corresponding liability of \$9,687.80 with unexpired interest of 842.63. Monthly repayment instalments are recorded in the Profit & Loss report for the amount of \$811.47. As the finance arrangement was entered into in March 2021 only 4 instalments have been recorded in the 2021 year with the remaining 8 instalments to be paid in the 2022 year.
